# **Drug-related Harms at Canadian Music Festivals**

### **Summary**

- Between June and August 2014, at least five young adults died while attending Canadian music festivals; many more individuals were treated onsite or admitted to hospital.
- It is suspected that drug use was a contributing factor in these deaths and illnesses.
- The CCENDU network attempted to compile detailed reliable information on drug-related deaths and illnesses that occurred at these festivals; however, investigations are ongoing and as of September 2014 very little information is available.
- A complete description of drug-related deaths and illnesses that occurred during the 2014
   Canadian music festival season is warranted when the information becomes available.
- There is a need to discuss and review practices for preventing and responding to drugrelated deaths and illnesses at these music festivals.
- CCENDU and the Canadian Centre on Substance Abuse (CCSA) are interested in collaborating with partners to assemble and share this information. Anyone who has information or is interested in becoming involved should contact CCENDU@ccsa.ca.

# **Background**

Summer music festivals are held throughout Canada every year. These festivals are often large, with as many as 70,000 tickets sold. Media reports indicate that between June and August 2014, many festival attendees were treated onsite by volunteer or contracted medical services, and a large number were transported to hospital for alcohol and other drug-related health issues. There have also been at least five deaths (19–24 years of age) in which alcohol and/or other drug use is suspected to be a contributing factor. These deaths occurred in Toronto (Veld)<sup>1,2,3</sup> and Ottawa (Escapade),<sup>4</sup> Ontario, and in Penticton (Boonstock)<sup>2,5,6,7</sup> and Pemberton (Pemberton Music Festival),<sup>1,8</sup> British Columbia. Other deaths have also occurred at large music festivals in the United States (Ultra Music Festival)<sup>9</sup> and elsewhere (Future Music Festival; Glastonbury Festival).<sup>10,11</sup>

As of September 2014, there are many unanswered questions about these deaths and illnesses as investigations are ongoing. A complete description of drug-related deaths and illnesses occurring at large summer music festivals in Canada is warranted.

There does not appear to be any consistent national or provincial guidelines, or specific language within existing guidelines, aimed at preventing and responding to drug-related overdoses at these events. In many jurisdictions in Canada, permits for events and festivals are granted municipally, without a requirement for consistent minimum standards for health and safety. It is important to discuss and review practices for preventing and responding to drug-related deaths and illnesses at Canadian music festivals.

#### **Call to Action**

In response, CCENDU and CCSA have begun:

- Collecting information on drug-related deaths and illnesses that have occurred at Canadian summer music festivals; and
- Assembling a group of experts to identify lessons learned and to help inform the development of recommendations for preventing, preparing for, and responding to drugrelated overdoses at large festivals.
